1 Pursuant to the Stipulation for Entry of an Order of Permanent Injunction
2 against Robert E. Meyer, and all matters properly made part of the record:

3 **IT IS ORDERED** that pursuant to I.R.C. §§ 7402 and 7407, Meyer is
4 permanently barred from directly or indirectly:

- 5 i. Acting as a federal tax return preparer, preparing or filing federal tax
6 returns, amended returns, and other related tax documents and forms for
7 any entity or person other than himself;
- 8 ii. Managing, supervising, or assisting others in the preparation or filing of
9 federal tax returns, amended returns, and other related tax documents
10 and forms for any entity or person other than himself;
- 11 iii. Practicing before the Internal Revenue Service, as that term is defined
12 in 31 C.F.R. 10.2(a)(4);
- 13 iv. Representing any person or entity before the IRS other than himself;
- 14 v. Attempting to obtain or use a preparer identification number (PTIN) or
15 electronic filing identification number (EFIN) for any purpose; and
- 16 vi. Having any direct or indirect ownership interest in, or working for any
17 business that prepares tax returns for others or represents taxpayers
18 before the IRS.

19 **IT IS FURTHER ORDERED** that pursuant to I.R.C. §§ 7402 and 7408,
20 Meyer is permanently barred from directly or indirectly organizing, promoting,
21 marketing, or selling any plan or arrangement that advises taxpayers to overstate
22 federal income tax withholding, including by misuse of IRS Forms 1099-OID.

23 **IT IS FURTHER ORDERED** that Meyer shall file with the Court and

1 serve on counsel for the United States, within 45 days of the entry of this order, a
2 certification signed under penalty of perjury stating that he has received the
3 executed copy of this order.

4 **IT IS FURTHER ORDERED** that the United States may conduct post-
5 judgment discovery to monitor Meyer's compliance with the terms of this
6 injunction.

7 **IT IS FURTHER ORDERED** that Meyer shall not make any statements,
8 written or verbal, or cause or encourage others to make any statements, written or
9 verbal, that misrepresent any of the terms of this injunction.

10 **IT IS FURTHER ORDERED** that pursuant to Rule 65(d)(2) of the Federal
11 Rules of Civil Procedure, this order binds the following who receive actual notice
12 of it by personal service or otherwise:

- 13 i. the defendant, Robert E. Meyer;
- 14 ii. Meyer's agents, servants, employees, and attorneys; and
- 15 ~~iii~~ other persons who are in active concert or participation with anyone
16 described in (i) or ~~(ii)~~ above.

17 **IT IS FURTHER ORDERED** that Meyer has waived any and all right to
18 appeal from this judgment.
