WHEREAS Plaintiffs JBP SERVICES, P.C., a California Corporation, and JAMES B. PICKELL, as Trustee for JBP SERVICES, P.C. PROFIT SHARING 401(k) PLAN, a qualified retirement plan, (hereinafter collectively referred to as “Plaintiffs”)

1 on the one hand, and Defendants MICHAEL MURPHY, an individual, and Defendant

4 November 20, 2017, pursuant to a written “SETTLEMENT AGREEMENT AND
5 MUTUAL RELEASE” (hereinafter referred to as the “Settlement Agreement”);

7 **WHEREAS** Defendants executed a confession to judgment to be entered upon
8 any Default, as that term is defined in section 2(B) of the Settlement Agreement; and

10 **WHEREAS** Plaintiffs and Defendants executed a Stipulated Request for Entry
11 of Consent Judgment against Defendants;

13 **WHEREAS** Defendants are in Default;

14 **IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED THAT:**

- 16 1. The Court finds for Plaintiffs, and against Defendants; and,
17 2. Plaintiffs shall have and recover from Defendants MICHAEL MURPHY,
18 and AHTOVATION, INC., a Delaware Corporation, jointly and severally, a judgment
19 in the sum of **FIFTY-SIX THOUSAND TWO HUNDRED AND SIXTEEN AND**
20 **NO 0/100 DOLLARS (\$56,216.00)**, plus pre-judgment at the penalty rate of 18% per
21 annum from the date of default, plus attorneys’ fees and costs incurred by Plaintiffs in
22 entering and enforcing the money judgment after its entry.
