1 The Judgment entered in favor of Plaintiff Zurich American Insurance  
2 Company of Illinois on January 23, 2020 [Doc. 39], as amended on March 2, 2020  
3 [Doc. 43], is hereby further amended by the Court pursuant to the parties'  
4 Stipulation to Amend Judgment in the Event of Default, as follows:

5 The Court finds that 6 hours of work is appropriate for the work described  
6 in the affidavit. Affidavit of Lincoln v. Horton (Dkt. 67-1). At a reasonable rate of  
7 \$310.00 per hour, the Court awards \$1,860.00 in attorney's fees. Judgment entered  
8 on its complaint, as amended herein to add defendants FZX4ME, Inc. dba  
9 Workland Staffing and Sonya Lyn Green, and to reflect payment credits toward the  
10 previous amended judgment, in favor of Plaintiff Zurich American Insurance  
11 Company of Illinois and against and against Defendants Cad Green Acres  
12 Corporation dba People to People Staffing, FZX4ME, Inc. dba Workland Staffing  
13 and Sonya Lyn Green, jointly and severally, for a total of \$26,186.85 (consisting of  
14 \$24,309.65 in damages, \$1,860.00 in attorneys' fees, and \$17.20 in costs).
