1 Based upon the Petition to Enforce Internal Revenue Service Summons,
2 Memorandum of Points and Authorities, and supporting Declaration, the Court finds that
3 Petitioner has established a *prima facie* case for judicial enforcement of the subject
4 Internal Revenue Service (IRS) summons. See United States v. Powell, 379 U.S. 48, 57-
5 58, 85 S.Ct. 248, 255, 13 L.Ed.2d 112, 119 (1964).

7 **IT IS ORDERED** that Respondent appear before this District Court of the United

1 **IT IS FURTHER ORDERED** that copies of the following documents be served on

- 6 2. The Petition, Memorandum of Points and Authorities, and accompanying
7 Declaration.

9 Service may be made by any employee of the IRS or the United States Attorney's
10 Office.

12 **IT IS FURTHER ORDERED** that within ten (10) days after service upon
13 Respondent of the herein described documents, Respondent shall file and serve a written
14 response, supported by appropriate sworn statements, as well as any desired motions. If,
15 prior to the return date of this Order, Respondent files a response with the Court stating
16 that Respondent does not oppose the relief sought in the Petition, nor wish to make an
17 appearance, then the appearance of Respondent at any hearing pursuant to this Order to
18 Show Cause is excused, and Respondent shall comply with the summons within ten (10)
19 days thereafter.
