JUDGMENT

1 On October 14, 2022, the jury in this matter returned its unanimous verdict
2 finding: (1) in favor of Kolay Flooring International, LLC and Daniel Paul Mitchell
3 (“Plaintiffs”) and against Luis Barroso De La Fuente on Plaintiffs’ claim for Breach of
4 Fiduciary Duty; (2) in favor of Plaintiffs and against Pisos Kolay, S.A. DE C.V. on
5 Plaintiffs’ claim that Pisos Kolay conspired with Luis Barroso De La Fuente to breach
6 his fiduciary duties to Plaintiffs; (3) in favor of Lalur, S.A. DE C.V. and against
7 Plaintiff on Plaintiffs’ claim that Lalur conspired with Luis Barroso De La Fuente to
8 breach his fiduciary duties to Plaintiffs; (4) against Plaintiff and in favor of Luis
9 Barroso De La Fuente on Plaintiffs’ claim of Breach of Contract (Partly Written and
10 Partly Oral); and (5) against Plaintiff and in favor of Luis Barroso De La Fuente on
11 Plaintiffs’ claim of Breach of Contract (Implied Covenant of Good Faith and Fair
12 Dealing). (See Doc. 201.)

13 Having reviewed the jury’s verdict and having considered the uncontradicted
14 evidence admitted at trial regarding the formation of Lalur as the successor entity to
15 Pisos Kolay,

16 IT IS ORDERED, ADJUDGED AND DECREED:

17 1. Plaintiffs, Kolay Flooring International, LLC and Daniel Paul Mitchell,
18 shall recover from defendants Luis Barroso De La Fuente; Pisos Kolay, S.A. DE C.V.;
19 and Lalur, S.A. DE C.V. the amount of one dollar (\$1.00).

20 2. No party shall be deemed the prevailing party, and each shall bear his or its
21 own costs.

23 IT IS SO ORDERED.


