1 **JUDGMENT**

2 On August 30, 2024, the court granted in substantial part Plaintiff Ameris
3 Bank, doing business as Balboa Capital Corporation’s (“Balboa”) Motion for
4 Default Judgment against Katia Soler (“Defendant”). Accordingly, having
5 considered all the pleadings and papers filed in this case, the evidence on record
6 and argument of counsel, and the applicable law, and for the good cause appearing
7 therein, **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:**

8 Judgment is entered in this matter in favor of Balboa and against Defendant
9 in the total amount of **\$233,087.76**, which represents the sum of \$212,184.00 in
10 compensatory damages, \$12,556.08 in prejudgment interest, \$7,843.68 in attorney
11 fees, and \$504.00 in costs.
