4 Any reply papers in support of cross-motions for summary judgment shall be served and filed on
5 or before Wednesday, February 9, 2011; and

6 The hearing on all motions for summary judgment shall be on Monday, February 28, 2011, at
7 10:00 am in Courtroom 3.
