(See ECF No. 225.) 20 On November 30, 2021, the Court issued an order referring the case to the Selection 21 Board for the Eastern District of California (hereinafter "Selection Board") for 22 recommendation of suitable counsel, with consideration to be given the Sacramento Office of 23 the Federal Public Defender. (ECF No. 226.) 24 25 On December 8, 2021, the Selection Board recommended that attorneys Ann-Kathryn R. Tria, CJA Capital Panel Member, and Sam Sweeney, Assistant Federal Defender, be 26 27 appointed to represent Petitioner. The Court will adopt the recommendation of the Selection Board. 28
