24 WHEREAS, Plaintiffs, Defendants, Cross-Defendants and Counter-Defendants
 25 CALIFORNIA EQUITY MANAGEMENT GROUP, INC. and FOX HOLLOW OF TURLOCK
 26 OWNERS ASSOCIATION and Defendant, Cross-Defendant and Counter-Defendant ANDREW
 27 KATAKIS (collectively the "CEMG/Fox Hollow Parties"), filed a Motion for Partial Summary
 28 Judgment re Cross-Complaint claims herein on February 4, 2011 [Docket #s 478 & 479];

1 WHEREAS, Cross-Complainants Richard Sinclair, Gregory Mauchley and Brandon
2 Sinclair (the "Cross-Complainants"), filed their opposition thereto on March 14, 2011 [Docket
3 #493 and 494] and the CEMG/Fox Hollow Parties filed their reply on March 21, 2011 [Docket #s
4 503, 504, 505, 506, 507 and 508], and therefore the briefing on such motion has been completed;

5 WHEREAS, the Court, by Minute Order filed March 21, 2011, vacated the hearing on
6 such motion set for April 4, 2011, and directed that a new date for the motion would be discussed
7 at a hearing on other motions on April 11, 2011;

8 WHEREAS, Mr. Sinclair filed an ex parte application received by the Court on Monday
9 morning, April 11, 2011, to continue the April 11, 2011 hearing and the Court issued its Minute
10 Order continuing the hearing set for April 11, 2011, to 12:15 p.m. on Tuesday, April 12, 2011;
