 16 matter before Judge Sandra M. Snyder. At the conclusion of the hearing the court
 17 set out a briefing schedule for the parties to submit closing arguments.

18 Counsel for petitioner Vargas was appointed under the Criminal Justice Act
 19 (CJA). It is necessary for petitioner Vargas' counsel to obtain a transcript of the
 20 evidentiary hearing to complete this brief. Counsel has been advised by the CJA
 21 panel administrator that an order from this court is required directing the U. S.
 Marshal to pay for the costs of petitioner's transcript of the evidentiary hearing.
