On March 31, 2009, an order was issued consolidating cases 1:06-cv-00205-AWI-GBC and 1:07-cv-01714-LJO-SMS. 18 19 (Doc. 27.) Upon reviewing the cases it has been determined that although both cases allege some 20 similar incidents, case 1:07-cv-01714-LJO-SMS includes unrelated claims against different 21 defendants that may not be joined with 1:06-cv-0205-AWI-GBC. 22 Based on the foregoing it is HEREBY ORDERED that: Cases 1:06-cv-00205-AWI-GBC PC and 1:07-cv-01714-LJO-SMS PC be severed; 23 1. 24 and 25 2. The Clerk's Office is ordered to: 26 a. Reopen case 1:07-cv-01714; and Designate cases 1:06-cv-00205-AWI-GBC and 1:07-cv-01714 as related; and 27 b. 28 Assign the actions to the same district judge and magistrate judge; and c. 1

1		d. Send Plaintiff a civil rights complaint form; and
2		e. File a copy of this order in case 1:07-cv-01714-LJO-SMS; and
3	3.	Within thirty (30) days from the date of service of this order, Plaintiff shall file an
4		amended complaint in case 1:07-cv-01714-LJO-SMS; and
5		a. The amended complaint is not to exceed 10 pages; and
6		b. The amended complaint must comply with the Federal Rules of Civil
7		Procedure and the Local Rules; and
8	4.	If Plaintiff fails to file an amended complaint in compliance with this order, 1:07-cv-
9		01714 will be dismissed for failure to state a claim.
