17	Plaintiff Frank Gonzales, a state prisoner proceeding pro se and in forma		
18	pauperis, filed this civil rights action on October 13, 2006 pursuant to 42 U.S.C. \S		
19	1983. (ECF No. 1.) The action proceeds on Plaintiff's December 24, 2009 Third		
20	Amended Complaint (ECF No. 37) against Defendants Lantz, Garrison, Nichols,		
21	Deathriage, and Govea for First and Eighth Amendment violations and against Defendants Garza, Franco, Mayes, Cate, Fernando, Marrujo, and Fuentes for a First		
22	Amendment violation. (ECF No. 62.)		
23	On May 6, 2013, a document characterized as "Plaintiff's Notice of Change of		
24	Address" (ECF No. 101) was filed by a third party.		
25 26	Plaintiff is proceeding pro se and must act personally, not by or through a third		
26 27	party. Fed. R. Civ. P. 11(a); Local Rule 131(b); Local Rule 183(a). Thus, the "Notice of

1	Change of Address" document is not a properly filed document and shall be stricken		
2	from the record. Id. Plaintiff may not use any address other than his own for his		
3	address in this case unless he is represented by an attorney who formally appears in		
4	the action as his attorney. Pro se litigants such as he generally are precluded from		
5	using an address other than their place of incarceration. Local Rule 183(a)(b).		
6	Plaintiff is to file a notice advising the Court of his correct current address. Local		
7	Rule 183(b).		
8	Accordingly, it is HEREBY ORDERED that:		
9	1.	Plaintiff's Notice of Change of	Address (ECF No. 101) is STRICKEN
10		from the record;	
11	2.	Plaintiff is directed to sign and	file a notice of his current address within
12	thirty days from service of this Order;		
13	3.	If Plaintiff fails to comply with	this Order his instant action may be
14		dismissed for failure to prosec	cute; and
