ORDER DIRECTING SERVICE OF
SUBPOENA ON WITNESS **ROGER LOW**
BY THE UNITED STATE MARSHAL
WITHOUT PREPAYMENT OF COSTS

16 Plaintiff is proceeding pro se in this civil rights action. Plaintiff has submitted the
17 required money orders made payable to the witness **Roger Low** being commanded to appear at
18 trial on August 23, 2011. The Court will use the address provided by Plaintiff. See Doc. 49.
19 Accordingly, IT IS HEREBY ORDERED that:

- 20 1. The Clerk of the Court is directed to forward the following documents to the
21 United States Marshal:

- 22 (1) One completed and issued subpoena to be served on **Roger Low**;
23 (2) One completed USM-285 form;
24 (3) One money order #14-231840681 in the amount of \$ 209.00, made
25 payable to **Roger Low**; and
26 (4) One copy of this order for **Roger Low**, plus an extra copy for the
27 Marshal.

- 28 2. Within **TEN** days from the date of this order, the United States Marshal is

1 directed to serve the subpoena and money order on **Roger Low** in accordance
2 with the provisions of Rule 45 of the Federal Rules of Civil Procedure.

3 3. The U.S. Marshal is directed to retain the subpoena in their file for future use.

4 4. The United States Marshal shall personally serve process and a copy of this order
5 upon **Roger Low** pursuant to Rule 45 of the Federal Rules of Civil Procedure and
6 28 U.S.C. § 566(c) and shall command all necessary assistance from the
7 California Department of Corrections (CDC) to execute this order. The United
8 States Marshal shall maintain the confidentiality of all information provided by
9 the CDC pursuant to this order.

10 5. Within ten days after personal service is effected, the United States Marshal shall
11 file the return of service, along with the costs subsequently incurred in effecting
12 service. Said costs shall be enumerated on the USM-285 form and shall include
13 the costs incurred by the Marshal's office for photocopying additional copies of
14 the subpoena and for preparing new USM-285 forms, if required.

15 IT IS SO ORDERED.
