Plaintiff is a state prisoner proceeding pro se who filed a civil rights action pursuant to 42 U.S.C. § 1983 on February 5, 2007. The matter has been referred to the Magistrate Judge pursuant to 28 U.S.C. § 636(b) and Local Rules 72-302 and 72-304. Pending before the Court is Plaintiff's application to proceed in forma pauperis, filed on February 5, 2007.

Plaintiff's application was incomplete. The "Certificate of Authorized Officer" was blank and was not dated or signed. Further, Plaintiff did not submit a trust account statement. Plaintiff is required to submit an original, signed prison trust account statement that includes the entire six-month period

1 immediately preceding the filing of the complaint. See 28 U.S.C.
2 § 1915(a)(2). Plaintiff will be provided the opportunity either
3 to pay the \$350.00 filing fee or submit a completed application,
4 with a signed certificate, and an original certified copy of his
5 trust account statement covering the full six-month period in
6 support of his request to proceed in forma pauperis.

7 In accordance with the above, IT IS HEREBY ORDERED that
8 within thirty days of the date of service of this order,
9 Plaintiff shall either submit a completed application to proceed
10 in forma pauperis, including a signed certificate and an original
11 certified copy of his prison trust account statement for the six-
12 month period immediately preceding the filing of the complaint,
13 or, in the alternative, pay the \$350.00 filing fee for this
14 action; further, the Clerk SHALL SEND to Plaintiff a blank
15 application to proceed in forma pauperis for one who is in
16 custody.

17 Plaintiff's failure to comply with this order will result in
18 a recommendation that this action be dismissed.

19 IT IS SO ORDERED.
