As 20 discussed during that conference, 21 IT IS ORDERED that: 22 1. The Court grants an extension of time in relation to fact-discovery requests that 23 have already been served as follows: 24 i. Defendant has permission to file, no later than **June 12, 2020**, a motion to 25 compel regarding any discovery requests already served on Plaintiff that 26 were discussed during the April 23, 2020, informal discovery dispute 27 conference. 28

ii. A hearing on said motion is set for <u>June 19, 2020, at 10:00 a.m.</u>, in Courtroom 10 (EPG) before Magistrate Judge Erica P. Grosjean. To participate telephonically, each party is directed to use the following dial-in number and passcode: 1-888-251-2909; passcode 1024453. The parties are reminded to file a joint statement regarding discovery disagreement one full week prior to the hearing and email a copy of same, in Word format, to epgorders@caed.uscourts.gov, for the Judge's review.¹

- 3. Defendant Jean Noll's motion for an extension of time (ECF No. 516) is denied to the extent the relief requested is inconsistent with this order.
- 4. Defendant 's motion for follow-up psychological examination of Plaintiff Shelly Ioane (ECF No. 518) is denied without prejudice.
- 5. After reviewing Plaintiff's expert disclosures, Defendant may file a motion for a supplemental psychological examination of Plaintiff Shelly Ioane. If Defendant wishes to file such a motion, Defendant must contact Courtroom Deputy Michelle Rooney (mrooney@caed.uscourts.gov) by **August 26, 2020**, to request an expedited briefing and hearing schedule.
