16 Plaintiff Rodolfo Anderson is a state prisoner proceeding pro se and in forma pauperis.  
17 On May 15, 2007, plaintiff filed a complaint alleging a violation of plaintiff's constitutional  
18 rights. Review finds that the complaint states a cognizable claim for relief pursuant to 42 U.S.C.  
19 § 1983 and 28 U.S.C. § 1915A(b). If the allegations of the complaint are proven, plaintiff has a  
20 reasonable opportunity to prevail on the merits of this action.

21 In accordance with the above, IT IS HEREBY ORDERED that:

22 1. Service is appropriate for the following defendants:

23 a. Dr. Talisman

24 b. Rn. Leblue

25 2. The Clerk of the Court shall send plaintiff 2 USM-285 forms, one summons,  
26 an instruction sheet and a copy of the complaint filed May 15, 2007.

3. Within thirty-five (35) days from the date of this order, plaintiff shall complete the attached Notice of Submission of Documents and submit the following documents to the court:

- a. The completed Notice of Submission of Documents;
- b. One completed summons;
- c. One completed USM-285 form for each defendant listed in number 1 above; and
- d. 3 copies of the endorsed complaint filed May 15, 2007.

4. Plaintiff need not attempt service on defendants and need not request waiver of service. Upon receipt of the above-described documents, the court will direct the United States Marshal to serve the above-named defendants pursuant to Federal Rule of Civil Procedure 4 without payment of costs.
