17	Sid Landau ("Plaintiff") is a civil detainee proceeding pro se in this civil rights action

20	Allen remain in this action.

1	Federal Rule of Civil Procedure 55 regarding Defendant Allen. (Id.)		
2	II. Order To Show Cause		
3	Within thirty days from the date of service of this order, Plaintiff shall show cause why		
4	Defendant Wendy Allen should not be dismissed from this action for Plaintiff's failure to		
5	prosecute against her.		
6	In accordance with the above, IT IS HEREBY ORDERED that:		
7	1. Within thirty days from the date of service of this order, Plaintiff shall file a		
8	written response to the court, showing cause why Defendant Wendy Allen should		
9	not be dismissed from this action for Plaintiff's failure to prosecute against her;		
10	and		
11	2. Plaintiff's failure to comply with this order shall result in a recommendation of		
12	dismissal of Defendant Wendy Allen from this action.
