Plaintiff Leroy Dewitt Hunter, a prisoner proceeding pro se and in forma pauperis, filed this civil rights action pursuant to 42 U.S.C. § 1983 on August 3, 2007. On May 23, 2012, the Court ordered Plaintiff to show cause why this action should not be dismissed for failure to prosecute. Plaintiff was given thirty days within which to respond. On May 29, 2012, a response was filed bearing the printed signature "Sincerely, Law Clerk" with initials. (Doc. 56.)

Filings may not be signed and submitted on behalf of Plaintiff by another individual. Fed. R. Civ. P. 11(a). Plaintiff is proceeding pro se and he is required to sign all filings. <u>Id.</u> Therefore, the response shall be stricken from the record.

Plaintiff's address of record is Kern Valley State Prison and the Court notes that the address on the filing is Kern County's Lerdo facility in Bakersfield. As a courtesy, the Court will direct the Clerk's Office to serve Plaintiff at both addresses. **However, Plaintiff is obligated to notify the Court of any change to his address and the Court will <u>not</u> change his address of record based on a filing signed by a third party.**
