FIRST INFORMATIONAL ORDER

Plaintiff is a civil detainee proceeding pro se and in forma pauperis in this civil rights action pursuant to 42 U.S.C. § 1983. In litigating this action, the parties must comply with the Federal Rules of Civil Procedure (Fed. R. Civ. P.) and the Local Rules of the United States District Court, Eastern District of California (Local Rules). This order highlights specific rules of which the parties should take particular note. FAILURE TO COMPLY WITH THE FEDERAL RULES, LOCAL RULES, OR A COURT ORDER, INCLUDING THIS ORDER, WILL BE GROUNDS FOR APPROPRIATE SANCTIONS, UP TO AND INCLUDING DISMISSAL OF THIS ACTION. Local Rule 11-110; Fed. R. Civ. P. 41(b).

1. Documents intended to be filed with the court by pro se litigants must be mailed to the Clerk of the Court. Local Rule 5-133(d)(1). All documents improperly mailed to a judge’s chambers will be

1 stricken from the record.¹ A document requesting a court order must be styled as a motion, not a letter.
2 Fed. R. Civ. P. 7.

3 2. Each document submitted for filing must include the original signature of the filing party or
4 parties. Local Rule 7-131; Fed. R. Civ. P. 11(a). All documents submitted without the required
5 signature(s) will be stricken. Each separate document must be bound separately at the top left corner.
6 Local Rule 7-130(b). If a document is bound behind another document, it will not be filed and will not
7 enter the court docket.

8 3. All paper documents filed with the court must be submitted with an additional legible
9 conformed copy for the court's use. Local Rule 5-133(d)(2). If the filing party wishes the court to return
10 a file-stamped copy, he or she must include an additional copy for that purpose (i.e., submit an original
11 and two copies, one for the court's use and one to be returned) AND a pre-addressed postage paid
12 envelope. The court cannot provide copy or mailing service for a party, even for an indigent plaintiff
13 proceeding in forma pauperis. Copies of documents from the court file may be obtained at the cost of
14 fifty cents per page.

15 4. After defendants have appeared in an action by filing a response to the complaint (i.e., an
16 answer, a motion to dismiss, or a motion for summary judgment), all documents filed with the court
17 must include a certificate of service stating that a copy of the document was served on the opposing
18 party. Fed. R. Civ. P. 5; Local Rule 5-135. A document submitted without the required proof of service
19 will be stricken. Where a party is represented, service on the party's attorney of record constitutes
20 effective service.

21 5. All filings must bear the file number assigned to the action, followed by the initials of the
22 District Court Judge and the Magistrate Judge to whom the case is assigned and the letter "P." Where
23 plaintiff simultaneously pursues more than one action, he or she must file separate original documents
24 and the appropriate number of copies in each action to which the document pertains. Documents
25 submitted listing more than one case number in the caption will be stricken.

26 6. The court cannot serve as a repository for the parties' evidence (i.e., prison or medical records,

1 witness affidavits, etc.). The parties may not file evidence with the court until the course of litigation
2 brings the evidence into question (for example, on a motion for summary judgment, at trial, or when
3 requested by the court). Evidence improperly submitted to the court will be stricken.

4 7. The Eastern District of California converted to an electronic filing, service, and storage
5 system, effective January 3, 2005. Pro se litigants are exempt from the electronic filing requirement and
6 must submit all documents to the court in paper. Local Rule 5-133(b)(2). Paper documents submitted
7 by pro se litigants for filing will be scanned into the electronic court file by the Clerk's Office. After
8 being scanned into the electronic court file, the paper documents will be retained in the Clerk's Office
9 for a limited period of time and then discarded. Local Rule 39-138(d). For this reason, pro se litigants
10 are cautioned not to send original exhibits to the court. When it is appropriate for pro se litigants to
11 submit exhibits to the court (see paragraph 6), the litigants shall retain their original exhibits and send
12 photocopies to the court.

13 8. After an answer is filed, the court will issue an order opening discovery, and setting the
14 deadlines for completing discovery, amending the pleadings, and filing pre-trial dispositive motions.
15 No discovery may be conducted without court permission until an answer is filed and the court issues
16 the discovery order. Discovery propounded on a party is self-executing, and must be served directly on
17 the party from whom discovery is sought; parties should not file copies of their discovery with the court.
18 Local Rules 33-250, 34-250, 36-250. Discovery documents inappropriately submitted to the court will
19 be stricken. Where the response to discovery is unsatisfactory, the party seeking discovery may file a
20 motion to compel discovery, including a copy of the discovery propounded and the response thereto.
21 Fed. R. Civ. P. 37. A motion to compel must be accompanied by "a certification that the movant has
22 in good faith conferred or attempted to confer with the party not making the disclosure in an effort to
23 secure the disclosure without court action." Fed. R. Civ. P. 37(a)(2)(A). A discovery motion that does
24 not comply with all applicable rules will be stricken and may result in imposition of sanctions.

25 9. Because plaintiff is detained and proceeds pro se, all pre-trial motions will be submitted
26 without a hearing. Local Rule 78-230(m). The parties are referred to Local Rule 78-230(m) for the
27 briefing schedule on motions.

1 10. All court deadlines will be strictly enforced. Requests for time extensions must state the
2 reason the extension is needed and must be filed with the court before the deadline in question. Local
3 Rule 6-144.

4 11. A pro se plaintiff has an affirmative duty to keep the court and opposing parties apprised of
5 his or her address. Local Rule 83-182(f). If a plaintiff moves and fails to file a notice of change of
6 address, service of court orders at plaintiff's prior address shall constitute effective notice. Id. If mail
7 directed to plaintiff is returned by the U.S. Postal Service as undeliverable, the court will not attempt
8 to re-mail it. If the address is not updated within sixty days of the mail being returned, the action will
9 be dismissed for failure to prosecute. Local Rule 83-183(b).

10 12. Pursuant to the in forma pauperis statute, "the court shall dismiss the case at any time if the
11 court determines that . . . the action . . . (i) is frivolous or malicious; (ii) fails to state a claim upon which
12 relief may be granted; (iii) or seeks monetary relief against a defendant who is immune from such relief."
13 28 U.S.C. § 1915(e)(2)(B). The court will direct the United States Marshal to serve plaintiff's complaint
14 only after the court has screened the complaint and determined that it contains cognizable claims for
15 relief against the named defendants. The court has a large number of civil rights cases pending before
16 it and will screen plaintiff's complaint in due course.

17 IT IS SO ORDERED.
