19 Plaintiff Steven De Shazo ("Plaintiff") is a state prisoner proceeding pro se and in
20 forma pauperis in this civil rights action pursuant to 42 U.S.C. § 1983. On March 7, 2011,
21 the Court granted Plaintiff's request for an extension of time to respond to Defendants'
22 discovery. (ECF No. 48.) Presently before the Court is Plaintiff's Motion for Correction of
23 Court Order stating that the Court misunderstood Plaintiff's prior request. (ECF No. 50.)
24 He did not need additional time to respond to discovery; rather, he wanted additional time
25 to conduct discovery. Plaintiff has also filed a separate Motion for Extension of Time to
26 conduct discovery. (ECF No. 51.)

1 The Court's prior Discovery and Scheduling Order stated that all discovery was to
2 be completed by January 7, 2011 and that dispositive motions were to be filed by March
3 16, 2011. (ECF No. 22.) However, the parties now represent that, because Defendants'
4 motion to dismiss was not resolved by the Court until March 24, 2011, they have not yet
5 conducted any discovery. Accordingly, the Court GRANTS both of Plaintiff's motions. The
6 Court's May 7, 2010 Discovery and Scheduling Order is AMENDED as follows:
7

8 1. The deadline for completion of all discovery, including filing motions to
9 compel, shall be **June 30, 2011**;

10 2. The deadline for filing pre-trial dispositive motions shall be **August 15, 2011**.

11 The parties are on notice that all requests for extensions of these deadlines must
12 be filed **before** the expiration of the deadline in question. Extensions of time will be
13 granted only on a showing of good cause.
