2 **RECORD:**

3 **IT IS HEREBY STIPULATED** by and between Plaintiffs and  
4 Defendants Taco Bell Corp. and Taco Bell of America, Inc. (“Defendants”), through

6 **Mediation/Status Conference**

7 WHEREAS, the Parties had agreed to mediate this case with mediator
