20	§ 1915A. Plaintiff filed a timely Objection on August 19, 2010.		
21	In accordance with the provisions of 28 U.S.C. § 636(b)(1)(C), the Court has conducted a de		
22	<u>novo</u> review of this case. Having carefully reviewed the entire file, the Court finds the Findings and		
23	Recommendations to be supported by the record and by proper analysis.		
24	Accordingly, IT IS HEREBY ORDERED that:		
25	1. The Findings and Recommendations, filed August 3, 2010, is adopted in full;		
26	2. This action shall proceed on Plaintiff's Amended Complaint, filed January 15, 2010,
