23	without prejudice to renewal of the motio	on at a later stage of the proceedings. Id. The deadline
24	for conducting discovery in this action ex	pired on November 30, 2010. Therefore, good cause
25	appearing, Plaintiff's request to renew his motion for summary judgment shall be granted.	
26	Plaintiff is advised that the renewed motion must be complete in itself, without reference to the	
27		wed motion on or before the deadline in this action for

1	Plaintiff also requests the court to issue an order requiring defendants to file a response to	
2	Plaintiff's renewed motion. Defendants are not required to respond to the renewed motion until	
3	after Plaintiff has filed it. Local Rule 230(1). Therefore, this request is denied.	
4	Accordingly, good cause appearing, IT IS HEREBY ORDERED that:	
5	1. Plaintiff's request to renew his motion for summary judgment, filed on December	
6	2, 2010, is GRANTED;	
7	2. Plaintiff is GRANTED leave to file a new motion for summary judgment, on or	
8	before the deadline to file pretrial dispositive motions; ¹ and	
9	3. Plaintiff's request for a court order requiring defendants to respond to his renewed	
10	motion is DENIED without prejudice.
