19 On March 3, 2016, the Court issued an amended order for the issuance of a Writ of
20 Habeas Corpus *ad Testificandum* to transport Plaintiff Kelvin X. Singleton, commanding the
21 Warden of the Richard J. Donovan Correctional Facility (RJD), 480 Alta Road, San Diego, CA
22 92179 to produce California prisoner Kelvin X. Singleton, CDCR #H-86959, to attend a
23 settlement conference in this action before Magistrate Judge Kendall J. Newman on March 29,
24 2016, at the United States District Court in Sacramento, California. (ECF No. 269.)

25 Instead of appearing in person at the settlement conference, Plaintiff shall appear
26 telephonically. Therefore, it is not necessary for Plaintiff to be transported to Court for the
27 settlement conference. By separate order, the Court has vacated the order and Writ issued on
28 March 3, 2016. (ECF No. 271.)

1 Accordingly, IT IS ORDERED that:

2 1. Plaintiff Kelvin X. Singleton shall appear telephonically at the settlement
3 conference for this action on March 29, 2016 at 1:30 p.m.;

4 2. Counsel for Plaintiff is required to arrange for the participation of Plaintiff in the
5 telephonic conference;

6 3. Plaintiff's counsel is advised to spend ample time before the hearing, contacting
7 prison employees ahead of time to ensure that Plaintiff is connected for the telephonic hearing
8 at the scheduled time; and

9 4. Prison employees and the Litigation Coordinator at the Richard J. Donovan
10 Correctional Facility are directed to arrange for inmate Kelvin X. Singleton, CDCR # H-86959
11 to participate telephonically in the settlement conference for this case on March 29, 2016 at
12 1:30 p.m.; and

13 5. The Clerk of Court is directed to serve a copy of this order on the Litigation
14 Coordinator at the Richard J. Donovan Correctional Facility.
