ORDER DENYING PLAINTIFF'S
MOTION FOR PRELIMINARY
INJUNCTIVE RELIEF, OR IN THE
ALTERNATIVE, MOTION TO COMPEL
DEFENDANTS TO SUBMIT
DOCUMENTS FOR *IN CAMERA*
REVIEW
(Docs. 140, 141.)

20 Sergio Alejandro Gamez ("Plaintiff") is a state prisoner proceeding pro se and in forma
21 pauperis with this civil rights action pursuant to 42 U.S.C. § 1983. On October 28, 2013,
22 findings and recommendations were entered, recommending that Plaintiff's motion for
23 preliminary injunction be denied. (Doc. 143.) On November 8, 2013, Plaintiff filed objections
24 to the findings and recommendations. (Doc. 146.)

25 In accordance with the provisions of 28 U.S.C. § 636 (b)(1)(B) and Local Rule 304, this
26 Court has conducted a de novo review of this case. Having carefully reviewed the entire file,
27 including Plaintiff's objections, the Court finds the findings and recommendations to be
28 supported by the record and proper analysis. Moreover, the defendants in this action are

1 employees at the California Correctional Institution in Tehachapi, California (CCI). According
2 to Plaintiff's address of record at the Court, Plaintiff is now housed at Corcoran State Prison in
3 Corcoran, California (CSP).¹ Because prison officials at CSP are now charged with housing
4 Plaintiff, his motion for a court order prohibiting acts by officials at CCI is moot.

5 Accordingly, THE COURT HEREBY ORDERS that:

- 6 1. The Findings and Recommendations issued by the Magistrate Judge on October
7 28, 2013, are ADOPTED IN FULL; and
- 8 2. Plaintiff's motion for preliminary injunctive relief, or in the alternative, motion
9 to compel, filed on October 24, 2013, is DENIED.
