DISCOVERY AND MODIFYING THE
SCHEDULING ORDER ENTERED

Upon good cause shown and pursuant to agreement of the parties,

IT IS HEREBY ORDERED THAT the United States' Motion to Extend Discovery is GRANTED.

IT IS HEREBY ORDERED THAT all discovery must be completed by November 6, 2009.

1 IT IS FURTHER ORDERED THAT all Non-Dispositive Pre-trial Motions,
2 including any discovery motions, will be filed on or before November 19, 2009, and
3 heard on December 4, 2009, at 9:00 a.m. before Magistrate Judge Dennis L. Beck in
4 Courtroom 9.

5 IT IS FURTHER ORDERED THAT a Settlement Conference is scheduled for
6 December 1, 2009, at 10:00 a.m. in Courtroom 9 before the Honorable Dennis L. Beck,
7 United States Magistrate Judge. At least five days prior to the Settlement Conference,
8 the parties shall submit, directly to the Magistrate Judge's chambers, a confidential
9 settlement conference statement as outlined in the Court's December 31, 2008,
10 scheduling order.

11 IT IS FURTHER ORDERED THAT all Dispositive Pre-Trial Motions are to be
12 filed no later than December 14, 2009, and will be heard on January 18, 2010, at 10:00
13 a.m. before the Honorable Oliver W. Wanger, United States District Judge, in
14 Courtroom 3, 7th Floor.

15 IT IS FURTHER ORDERED that the Pre-Trial Conference will be held on
16 February 22, 2010, at 11:00 a.m. in Courtroom 3, 7th Floor, before the Honorable Oliver
17 W. Wanger, United States District Judge. The parties are ordered to file a Joint Pre-
18 trial statement pursuant to Local Rule 281(a)(2).

19 IT IS FURTHER ORDERED that Trial in this matter is set for March 30, 2010, at
20 9:00 a.m. in Courtroom 3, 7th Floor, before the Honorable Oliver W. Wanger, United
21 States District Judge.
