STIPULATION

Plaintiff ANTONIA LUNA and Defendants BLIATOUT LLC and
HOA TRUNG VO dba SAVE MORE 98 DISCOUNT STORE hereby jointly
stipulate and request through their attorneys of record as follows:

On November 17, 2010, the Court issued its Order on Plaintiff's 9 Motion for Summary Judgment and Related Orders (the "Order" – Docket No. 10 46), in which the Court ordered: (1) the parties to meet and confer not later than 11 fourteen (14) days from the date of the Order to discuss the issues addressed in 12 the Order and any issues that may benefit resolution of the case; and (2) Plaintiff 13 to file and serve any proposed stipulated judgment or amended motion for 14 summary judgment or summary adjudication together with any stipulated 15 undisputed material facts not later than twenty-eight (28) days from the date of 16 the Order (by December 15, 2010). 17

On November 30, 2010 counsel for the parties met and conferred
telephonically to discuss Defendants stipulating to judgment in this case. On
December 6, 2010, Defendants confirmed that they will agree to a stipulated
judgment.

On December 7, 2010, counsel for Plaintiff forwarded defense
counsel a draft stipulated judgment. However, counsel for defendant Bliatout
LLC has been out of the office all this week and is unable to review the draft
stipulated judgment until next week.

In the interest of resolving the damages issue in this case and to allow the parties enough time to finalize mutually-acceptable language in a stipulated judgment, the parties hereby agree and stipulate that the deadline for
