19	On December 30, 2008, the Court issued an Order Re Consent or Request for		
20	Reassignment (Court Document #6-2) which was served on Plaintiff with information and		
21	instructions for informing the Court whether he would consent to Magistrate Judge Jurisdiction.		
22	The form instructs the parties to "Check and Sign <u>ONLY ONE</u> Section of the Form," indicating		
23	a choice between "consent" or "decline" as to jurisdiction of the Magistrate Judge. On January		
24	12, 2009, Plaintiff returned the Order Re Consent or Request for Reassignment form to the		
25	Court; however, plaintiff signed <u>BOTH</u> sections of the form. At this time, the Court shall		
26	require Plaintiff to complete a new Order Re Consent or Request for Reassignment form and		
27	return it to the Court.

1	Accordingly, IT IS HEREBY ORDERED that:		
2	1.	The Clerk of Court shall re-serve on Plaintiff the Order Re Consent or Request	
3		for Reassignment issued on December 30, 2008 (Court Document #6-2).	
4	2.	Within thirty (30) days from the date of service of this order, Plaintiff shall	
5		submit a new Order Re Consent or Request for Reassignment form, telling the	
6		Court whether he will consent to Magistrate Judge Jurisdiction. Plaintiff must	
7		sign <u>ONLY ONE</u> section of the form, indicating a choice between "consent" and	
8		"decline."	
9	3.	Failure to follow this order will result in a recommendation that this action be	
10		dismissed pursuant to Local Rule 11-110.
