This amount represents compensation for all legal services rendered on behalf of Plaintiff by 22 counsel in connection with this civil action, in accordance with 28 U.S.C. § 2412(d). 23 This stipulation constitutes a compromise settlement of Plaintiff's request for EAJA 2.4 attorney fees, and does not constitute an admission of liability on the part of Defendant under the 25 EAJA. Payment of ONE THOUSAND EIGHT HUNDRED EIGHT dollars and 52/100 cents 26 (\$1,808.52) in EAJA attorney fees, shall constitute a complete release from and bar to any and all 27 28

	claims Plaintiff may have relating to EAJA fees in connection with this action. Any payment

2	shall be made payable to Plaintiff's counsel as Plaintiff's assignee and delivered to Plaintiff's
3	counsel.
4	This award is without prejudice to the rights of Plaintiff's counsel to seek Social Security
5	Act attorney fees under 42 U.S.C. § 406, subject to the provisions of the EAJA.
