SEAL; CASE NO. 1:09-CV-00560-LJO-SMS

1 Defendant USS-POSCO Industries (“UPI”) has filed an ex parte application and motion for
2 an order allowing UPI to file its opposition to plaintiff Stanislaus Food Products Company’s
3 motion to remand and supporting documents under seal.
