25 The parties, by and through their attorneys of record, agree to extend the deadline to submit
26 the trial exhibits to August 17, 2012. Based on the pretrial order, dated March 20, 2012, the
27 Court ordered the parties to submit to the Courtroom Deputy their pre-marked trial exhibits by no
28 later than July 6, 2012. (ECF No. 72, 10:17-22.)

1 Good cause exists to extend this deadline because Plaintiff's counsel, who was recently
2 appointed to this case (ECF No. 92), requires more time to obtain evidence to prosecute this case
3 and prepare Plaintiff's exhibits. Also, the Court continued the trial to September 10, 2012, to
4 allow Plaintiff's counsel more time to prepare for trial. (ECF No. 102.) Thus, the requested
5 extension will not affect the trial date. The parties have met all other deadlines set out in the
6 Court's pretrial order.
