On March 25, 2013, the Court issued an order denying all 18 19 motions for reconsideration and sanctions. (Doc. 127). The parties submitted a joint status report on April 12, 2013, setting forth proposed deadlines for the action to proceed. (Doc. 131). The Court held 20 21 a status conference on April 19, 2013, and finds it is appropriate for the stay to be lifted, and the 22 scheduling order be amended. Accordingly, IT IS HEREBY ORDERED: 23 1. The stay entered on September 21, 2011 is **LIFTED**; 24 2. The Scheduling Order is amended as follows: 25 26 A. Defendant SHALL produce the documents ordered by the Court on April 30, 27 2012 (Docs. 110, 127, 130) by Defendant **in full**, no later than **May 1, 2013**;

4		C.	Plaintiff's motion for class certification SHALL be filed on or before August 2,

14		J.	Expert discovery SHALL be completed no later than March 24, 2014;
15		K.	Non-Dispositive pre-trial motions, including any discovery motions, SHALL be
16			filed no later than April 7, 2014, and heard on or before May 5, 2014;
17		L.	Dispositive pre-trial motions SHALL be filed on or before May 19, 2014, with
18			a hearing date no later than June 30, 2014;
19		M.	The Pre-Trial Hearing is SET for August 27, 2014 , at 8:30 a.m., in Courtroom 2
20			before Judge Ishii; and
21		N.	The Trial Date is SET for October 28, 2014, at 8:30 a.m., in Courtroom 2
22			before Judge Ishii.
