23 Motion to Strike Plaintiffs' Expert Witness Disclosure and Supplemental Expert Witness
24 Disclosure and to Preclude Plaintiffs' Experts from Testifying at Trial ("the Motion"), and good

26 IT IS ORDERED THAT:

- 27 1. The Ex Parte Application is GRANTED IN PART and DENIED IN PART.
28 2. The Court will hold a telephonic hearing on the motion on March 2, 2011 at 3:30

1 p.m. The parties SHALL appear by telephone by placing their conference call to Magistrate
2 Judge Thurston's chambers at (661) 326-6624 once all counsel are on the line. Counsel for the
3 moving parties SHALL arrange the conference call;

4 3. The time for service of the Motion and any opposition thereto, is shortened.

5 4. The Motion, including all supporting documents, SHALL be filed and served by e-
6 mail no later than noon on February 23, 2011. The motion SHALL not exceed five pages and the
7 supporting documentation SHALL not exceed 10 pages.

8 5. All papers opposing the Motion SHALL be filed and served by e-mail no later
9 than February 25, 2011. The opposing papers SHALL not exceed five pages and the supporting
10 documentation SHALL not exceed 10 pages.

11 6. No reply papers SHALL be filed.
