1 **[PROPOSED] ORDER**

2 Pacific Coast Federation of Fishermen’s Associations/Institute for Fisheries Resources, The  
3 Bay Institute, California Trout, Friends of the River, Natural Resources Defense Council, Northern  
4 California Council of the Federation of Fly Fishers, San Francisco Baykeeper, Sacramento River  
5 Preservation Trust, and the Winnemem Wintu Tribe (“Proposed Intervenors”) have moved to
