18 Pursuant to the request of the parties, a settlement
19 conference regarding attorney's fees and costs is HEREBY SET for
20 November 2, 2010 at 10:00 a.m. in Courtroom No. 9 before the
21 Honorable Dennis L. Beck, United States Magistrate Judge.

22 Plaintiff's counsel, Tanya Moore, and plaintiff, Theresa
23 Wallen, are permitted to participate telephonically. Ms. Moore is
24 DIRECTED to call Judge Beck's chambers directly at (559) 499-5672
25 on November 2, 2010 at 10:00 a.m. for further instructions.
26 Plaintiff, Theresa Wallen, is DIRECTED to be immediately available
27 by telephone on November 2, 2010 beginning at 10:00 a.m. until
28 excused by the Court. Defendant's counsel, Paul Hager, and

1 defendant, Amarjit Sangha, are ORDERED to be personally present on
2 November 2, 2010 at 10:00 a.m.

3 A Confidential Settlement Conference Statement is mandatory,
4 and must be submitted to Judge Beck's chambers by October 27, 2010,
5 via e-mail to DLBOrders@caed.uscourts.gov. Failure to so comply
6 may result in the imposition of monetary and/or other sanctions.

7 The Statement should not be filed with the Clerk's Office nor
8 served on any other party, although the parties may file a Notice
9 of Lodging Confidential Settlement Conference Statement. Each
10 Statement shall be clearly marked "Confidential" with the date and
11 time of the Settlement Conference indicated prominently thereon.
12 Counsel are urged to request the return of their Statements if
13 settlement is not achieved and, if such a request is not made, the
14 Court will dispose of the Statement.

15 The Confidential Settlement Conference Statement shall include
16 the following, if applicable for this particular and specific
17 conference:

18 A. A brief statement of the facts of the case.

19 B. A brief statement of the claims and defenses, i.e.,
20 statutory or other grounds upon which the claims are founded; a
21 forthright evaluation of the parties' likelihood of prevailing on
22 the claims and defenses; and, a description of the major issues in
23 dispute.

24 C. A summary of the proceedings to date.

25 D. An estimate of the cost and time to be expended for
26 further discovery, pretrial, and trial.

27 E. The relief sought.

1 F. The party's position on settlement, including present
2 demands and offers, and a history of past settlement discussions,
3 offers, and demands.
