STIPULATION AND ORDER
FOR EXTENSION OF TIME

17 **IT IS HEREBY STIPULATED** by the undersigned for the respective parties,
18 subject to the approval of the Court, that the Plaintiff, Paul A. Diaz, have
19 a 14-day extension of time in which to file a Reply to the Defendant
20 Commissioner's Opposition to Plaintiff's Motion for Attorney Fees, up to and
21 including July 7, 2011. This extension is being sought because the
22 undersigned counsel for the Plaintiff will be on a two-week vacation
23 beginning June 12 through June 26. In keeping with the initial scheduling
24 order in this Social Security case, Plaintiff's Reply to the Defendant's
25 Opposition is due 14 days after service of the Opposition. Defendant filed

27 2011. Given that the due date for Plaintiff's Reply falls on a day when
28 counsel for the Plaintiff will be out of the office and out of the country,

1 Counsel will be unable to complete the Plaintiff's Reply by the original June
2 23 due date. Plaintiff therefore respectfully requests that the Court
3 approve this stipulation for a 14-day extension of time for Plaintiff to
4 Reply to the Defendant's Opposition until July 7, 2011. This is the first
5 extension of time that Plaintiff has requested in this case.
