1 **STIPULATION REGARDING PRETRIAL MOTION DATES**

2 Plaintiffs Carrie Hawecker and Michelle Broussard (Private Plaintiffs), Plaintiff United
3 States of America, and Defendant Rawland Leon Sorensen continue to work towards finalizing a
4 consent decree to resolve these consolidated cases. The Defendant has represented that he is still
5 working to complete his financial disclosure statement, a prerequisite to finalizing a consent
6 decree, and will submit it to the plaintiffs as soon as possible. The parties hope to enter into a
7 final settlement by September 6, 2012.

9 In light of the anticipated settlement, the parties stipulate to the following changes in the
