1 IT IS THEREFORE ORDERED, ADJUDGED AND DECREED THAT THE Court's
2 Order (Doc. No. 40) filed on November 17, 2010, modifying the Court's Scheduling Order filed
3 on July 8, 2010 is further amended as follows:

- 4 1. The filing deadline for PLAINTIFF's Motion for Class Certification shall be
5 extended from on or before May 16, 2011 to on or before July 15, 2011;
- 6 2. The filing deadline for DEFENDANTS' Opposition to Motion for Class
7 Certification shall be extended from on or before July 18, 2011 to on or before
8 September 19, 2011;
- 9 3. The filing deadline for PLAINTIFF's Reply to Opposition to Motion for Class
10 Certification shall be extended from on or before August 15, 2011 to October 19,
11 2011;
- 12 4. The hearing on PLAINTIFF's Motion for Class Certification shall be moved from
13 September 19, 2011 to November 21, 2011 at 10:00 a.m. in Courtroom 3, or as
14 otherwise ordered by the Court in light of its schedule.
