ORDER GRANTING PLAINTIFF AN
EXTENSION OF TIME TO FILE
OBJECTIONS TO FINDINGS AND
RECOMMENDATIONS

(ECF NO. 75)

THIRTY DAY DEADLINE

15 Dougal Samuels (“Plaintiff”) is a civil detainee proceeding *pro se* and *in forma*
16 *pauperis* with this civil rights action filed pursuant to 42 U.S.C. § 1983. On July 24, 2017, the
17 Court issued findings and recommendations, recommending that Plaintiff’s section 1983 claim
18 against Fresno County Board of Supervisors be dismissed, and that the County of Fresno’s
19 motion to quash service of process be granted. (ECF No. 74).

20 On August 7, 2017, Plaintiff filed objections to the findings and recommendations, and
21 a request “for an extension of time in order to make proper service of defendants Fresno
22 County Board of Supervisor.” (ECF No. 75).¹ Plaintiff asks for thirty days so that he can
23 identify the individual members of the Fresno County Board of Supervisors and substitute them
24 in place of the Fresno County Board of Supervisors.

25 The Court will grant Plaintiff thirty days to file additional objections to the findings and
26 recommendations. In his objections, Plaintiff may identify the defendants he wants to

27 ¹ Based on Plaintiff’s objections, it appears that Plaintiff may believe that the Court found that
28 substituting the County of Fresno in place of the Fresno County Board of Supervisors would be improper. The
Court did not make this finding.

1 substitute into the case, and request that he be allowed to substitute them into the case. The
2 County of Fresno will be given seven days from the date the objections are filed in CM/ECF to
3 serve and file a reply to the objections.

4 Accordingly, based on the foregoing, IT IS ORDERED that Plaintiff has thirty days
5 from the date of service of this order to file additional objections to the findings and
6 recommendations. The County of Fresno has seven days from the date the objections are filed
7 in CM/ECF to serve and file a reply to the objections.
