III. Summary of Pleadings.

7 This is a civil rights action by Plaintiff Theresa 1. Wallen (hereinafter referred to as "Plaintiff") for 8 9 discrimination at the building, structure, facility, complex, property, land, development, and/or surrounding business complex 10 known as: BJ's Kountry Kitchen, located at 4944 North Blackstone 11 Avenue, Fresno, California (hereinafter referred to as the 12 "Store"). Plaintiff seeks damages, injunctive and declaratory 13 14 relief, attorneys' fees and costs, against Norberto Garcia and Teresa Garcia, dba BJ's Kountry Kitchen; and Prosperity 15 Properties TLC, LLC, owners and operators of the Restaurant 16 17 (hereinafter collectively referred to as "Defendants").

18 IV. Orders Re Amendments To Pleadings.

The parties do not anticipate amending the pleadings at
 this time. The parties propose that any amendments be
 accomplished on or before December 3, 2010.

V. Factual Summary.

22

A. Admitted Facts Which Are Deemed Proven Without FurtherProceedings.

25 1. There is no dispute that the Plaintiff is disabled
26 within the meaning of the Americans with Disabilities Act.

27 2. Defendants Norberto Garcia and Teresa Garcia are
28 individual residents of the Eastern District of California,

Fresno Division, and doing business under the fictitious name and 1 2 style BJ's Kountry Kitchen and Prosperity Properties TLC, LLC. 3. The Defendants own and operate a Restaurant under 3 that name and style. 4 5 4. The Restaurant is a public accommodation open to the public and intended for non-residential use whose operation 6 7 affects commerce. 5. The Defendants acknowledge that hidden 8 9 architectural features of the Restaurant do not comply with the 10 law. Β. Contested Facts. 11 12 1. All remaining facts are disputed. 13 VI. Legal Issues. 14 Α. Uncontested. 15 Jurisdiction exists under 28 U.S.C. §§ 1331 and 1. 1342 and the Americans with Disabilities Act. Supplemental 16 jurisdiction is invoked under 28 U.S.C. § 1367. 17 Venue is proper under 28 U.S.C. § 1391(b) and (c). 18 2. 19 3. The parties agree that the substantive law of the 20 State of California provides the rule of decision as to supplemental claims. 21 22 Β. Contested. All remaining legal issues are disputed. 23 1. VII. Consent to Magistrate Judge Jurisdiction. 24 25 1. The parties have consented to transfer the case to the 26 Magistrate Judge for all purposes, including trial. The case 27 number that must be typed on all pleadings filed in the case 28 after this date is: 1:10-cv-0732 SKO. 3

VIII. Corporate Identification Statement.

1. Any nongovernmental corporate party to any action in this court shall file a statement identifying all its parent corporations and listing any entity that owns 10% or more of the party's equity securities. A party shall file the statement with its initial pleading filed in this court and shall supplement the statement within a reasonable time of any change in the information.

The parties do not anticipate at this time that 1 1. 2 such protective order will be required. 3 F. Timing, Sequencing, Phasing or Scheduling of Discovery. The parties do not seek a timetable for discovery 4 1. outside of the Court's Scheduling Order. The parties do not 5 believe discovery should be conducted in phases or limited to 6 7 particular issues. Discovery Outside of the U.S. G. 8 9 1. The parties do not anticipate the need to take discovery outside the United States. 10 11 Η. Video and/or Sound Recording of Depositions. The parties anticipate that all depositions will 12 1. 13 be videotaped. Mid-Discovery Status Report and Conference. I. 14 15 Plaintiff proposes a date in February of 2001 for 1. status report and conference. 16 17 Discovery Relating to Electronic, Digital and/or J. 18 Magnetic Data. The parties do not anticipate at this time that 19 1. 20 such discovery will be required. 21 The Court orders: 22 The parties are ordered to complete all discovery on or 1. 23 before June 1, 2011. 24 2. The parties are directed to disclose all expert 25 witnesses, in writing, on or before April 1, 2011. Any rebuttal or supplemental expert disclosures will be made on or before May 26 27 2, 2011. The parties will comply with the provisions of Federal 28 Rule of Civil Procedure 26(a)(2) regarding their expert 5

designations. Local Rule 16-240(a) notwithstanding, the written designation of experts shall be made pursuant to F. R. Civ. P. Rule 26(a)(2), (A) and (B) and shall include all information required thereunder. Failure to designate experts in compliance with this order may result in the Court excluding the testimony or other evidence offered through such experts that are not disclosed pursuant to this order.

3. The provisions of F. R. Civ. P. 26(b)(4) shall
apply to all discovery relating to experts and their opinions.
Experts may be fully prepared to be examined on all subjects and
opinions included in the designation. Failure to comply will
result in the imposition of sanctions.

13 X. Pre-Trial Motion Schedule.

All Non-Dispositive Pre-Trial Motions, including any
 discovery motions, will be filed on or before June 15, 2011, and
 heard on July 13, 2011, at 9:30 a.m. before Magistrate Judge
 Sheila K. Oberto in Courtroom 8.

In scheduling such motions, the Magistrate
 Judge may grant applications for an order shortening time
 pursuant to Local Rule 142(d). However, if counsel does not
 obtain an order shortening time, the notice of motion must comply
 with Local Rule 251.

3. All Dispositive Pre-Trial Motions are to be
filed no later than July 1, 2011, and will be heard on August 3,
2011, at 2:00 p.m. before the Honorable Sheila K. Oberto, United
States Magistrate Judge, in Courtroom 8, 6th Floor. In
scheduling such motions, counsel shall comply with Local Rule
230.

Permission for a party [not attorney] to attend 8 9 by telephone may be granted upon request, by letter, with a copy to the other parties, if the party [not attorney] lives and works 10 outside the Eastern District of California, and attendance in 11 person would constitute a hardship. If telephone attendance is 12 allowed, the party must be immediately available throughout the 13 14 conference until excused regardless of time zone differences. To aid the court in the 26 27 efficient administration of this case, all counsel are directed 28 to familiarize themselves with the Federal Rules of Civil

Procedure and the Local Rules of Practice of the Eastern District
 of California, and keep abreast of any amendments thereto.
 XVIII. Effect Of This Order.

4 The foregoing order represents the best 1. estimate of the court and counsel as to the agenda most suitable 5 to bring this case to resolution. The trial date reserved is 6 7 specifically reserved for this case. If the parties determine at any time that the schedule outlined in this order cannot be met, 8 9 counsel are ordered to notify the court immediately of that fact so that adjustments may be made, either by stipulation or by 10 11 subsequent scheduling conference.

12 2. Stipulations extending the deadlines contained 13 herein will not be considered unless they are accompanied by 14 affidavits or declarations, and where appropriate attached 15 exhibits, which establish good cause for granting the relief 16 requested.

3. Failure to comply with this order may result in the imposition of sanctions.
