17 This matter is before the Court on plaintiff United States' *Ex Parte* Motion for Default
 18 Judgment and Final Judgment of Forfeiture filed November 5, 2010. The Magistrate Judge has
 19 recommended that the United States' motion for default judgment be granted. The time for objecting
 20 to the Findings and Recommendations Recommending the Granting of Plaintiff's Ex Parte Motion
 21 for Default Judgment have passed and no timely objections have been filed. An Order Adopting
 22 Findings and Recommendations was filed on January 14, 2011. Based on the Magistrate Judge's
 23 Findings and Recommendations Recommending the Granting of Plaintiff's Ex Parte Motion for
 24 Default Judgment, the Order Adopting Findings and Recommendations, and the files and records
 25 of the Court, it is

26 ORDERED, ADJUDGED, AND DECREED:

27 1. The Court adopts the Magistrate Judge's December 14, 2010, Findings and
 28 Recommendations Recommending the Granting of Plaintiff's Ex Parte Motion for Default Judgment

1 in full.

2 2. Jose Luis Palominos, Laura Chavez-Mendoza, and Sonia Mendoza are held in default.

3 3. A judgment by default is hereby entered against any right, title, or interest in the
4 defendant approximately \$10,923.00 in U.S. Currency of Jose Luis Palominos, Laura Chavez-
5 Mendoza, Sonia Mendoza, and all other potential claimants who have not filed claims in this action.

6 4. A final judgment is hereby entered forfeiting all right, title, and interest in the
7 defendant approximately \$10,923.00 in U.S. Currency, to be disposed of according to law, including
8 all right, title, and interest of Jose Luis Palominos, Laura Chavez-Mendoza, and Sonia Mendoza.

9 5. All parties shall bear their own costs and attorneys' fees.
