22 **WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED**  
 23 **THAT:**

24 1. On July 26, 2010, this Court granted the Motion to Dismiss Plaintiff’s  
 25 Complaint brought by Defendants, LITTON LOAN SERVICING LP (“Litton”) and U.S.  
 26 BANK NATIONAL ASSOCIATION AS SUCCESSOR TRUSTEE TO LASALLE  
 27 BANK NATIONAL ASSOCIATION, AS TRUSTEE FOR THE C-BASS MORTGAGE  
 28 LOAN ASSET-BACKED CERTIFICATES, SERIES 2007-CB5 (“U.S. Bank, As

1 Trustee”)(collectively as “Defendants”). Accordingly, the Complaint of Plaintiff,  
2 ANEESAH HASAN is dismissed with prejudice, in its entirety as to Defendants Litton  
3 and U.S. Bank, as Trustee;

4 2. Plaintiff shall take nothing; and

5 3. Defendants, if they so choose, may recover from Plaintiff, costs of suit to  
6 be determined by a duly filed memorandum of costs, monetary sanctions and attorney  
7 fees by motion.
