The parties respectfully submit this Stipulation and Proposed Order as follows:

The parties to the above captioned lawsuit participated in multiple settlement conferences and settled their dispute on May 18, 2011. On that date, the parties signed a six page Memorandum of Understanding which memorializes the settlement terms.
