23 The United States of America, Plaintiff herein, applies for an order of publication as follows:

24 1. Rule G(4) of the Supplemental Rules for Admiralty or Maritime Claims and Asset
 25 Forfeiture Actions (hereafter "Supplemental Rules") provides that the Plaintiff shall cause public
 26 notice of the action and arrest to be given in a newspaper of general circulation or on the official
 27 internet government forfeiture site;

1 2. Local Rule 171, Eastern District of California, provides that the Court shall designate
2 by order the appropriate newspaper or other vehicle for publication;

3 3. The above-captioned defendant real properties are located in the city of Alexandria,
4 in Rapides Parish, Louisiana;

5 4. Plaintiff proposes that publication be made as follows:

6 a. One publication;

7 b. Thirty (30) consecutive days;

8 c. On the official internet government forfeiture site www.forfeiture.gov;

9 d. The publication is to include the following:

10 (1) The Court and case number of the action;

11 (2) The date of posting of the real property;

12 (3) The identity and/or description of the real property posted;

13 (4) The name and address of the attorney for the Plaintiff;

14 (5) A statement that claims of persons entitled to possession or claiming
15 an interest pursuant to Supplemental Rule G(5) must be filed with the Court and served on the
16 attorney for the Plaintiff no later than 60 days after the first day of publication on the official internet
17 government forfeiture site; and

18 (6) A statement that answers to the Complaint or a motion under Rule 12
19 of the Federal Rules of Civil Procedure ("Fed. R. Civ. P.") must be filed and served within 21 days
20 after the filing of the claims and, in the absence thereof, default may be entered and condemnation
21 ordered.
