5	 within 120 days after the filing of the complaint, the court, upon motion or on its own initiative after notice to the plaintiff, shall dismiss the action without prejudice as to that defendant or direct that service be effected within a specified time; provided that if the plaintiff shows good cause for the failure, the court shall extend the time for service for an appropriate period.

9	More than 120 days have elapsed since Plaintiff filed the summons and complaint in this	
10	action. As of this date, 126 days have elapsed. Thus, this Court ORDERS Plaintiff, no later	
11	than February 9, 2011, to show cause in writing why Plaintiff has failed to: (1) file documents	
12	to show proof of service of the summons and complaint on the aforementioned Defendants to	
13	comply with Rule $4(l)$ of the Federal Rules of Civil Procedure; and (2) accomplish service of the	
14	summons and complaint on the aforementioned Defendants within 120 days of filing the	
15	complaint to comply with Rule 4(m) of the Federal Rules of Civil Procedure.	
16	Plaintiff is admonished that this Court will recommend dismissal of this action if	
17	Plaintiff fails to comply with this Order and to show good cause for his failure to	
18	accomplish service of the summons and complaint.
