) **ORDER REGARDING CLERK'S ISSUANCE

19 WHEREAS, a Verified Complaint for Forfeiture *In Rem* has been filed on October 6, 2010,  
20 in the United States District Court for the Eastern District of California, alleging that the defendant  
21 2007 Chevrolet Silverado 1500 Pickup Truck, VIN: 1GCEK14J27Z545955, California License  
22 No.8G37483 (hereafter "defendant vehicle") is subject to forfeiture to the United States pursuant  
23 to 21 U.S.C. § 881(a)(4) for one or more violations of 21 U.S.C. § 841 *et seq.*;


24 And, the Court being satisfied that, based on the Verified Complaint for Forfeiture *In Rem* and  
25 the affidavit of Drug Enforcement Administration Special Agent Anthony R. Ward, there is probable  
26 cause to believe that the defendant vehicle so described constitutes property that is subject to  
27 forfeiture for such violation(s), and that grounds for the issuance of a Warrant for Arrest of Articles  
28 *In Rem* exist, pursuant to Rule G(3)(b)(i) of the Supplemental Rules for Admiralty or Maritime
