MATHEW CATE, et al., (Doc. 49) 13 14 Defendants. 15 Plaintiff Carlos Villegas, a prisoner proceeding pro se and in forma pauperis, filed this 16 civil rights action pursuant to 42 U.S.C. § 1983 on October 14, 2010. This action is proceeding on 17 Plaintiff's amended complaint against Defendant Neubarth for acting with deliberate indifference 18 to Plaintiff's serious medical needs, in violation of the Eighth Amendment of the United States 19 Constitution. 20 On September 2, 2014, Plaintiff filed a notice of change of address in which he also 21 informed the Court that he lacks access to his legal material. The Court does not have jurisdiction 22 over prison officials at Terre Haute Correctional Institution and cannot order them to provide 23 Plaintiff with his property, as he requests. See e.g., Steel Co. v. Citizens for a Better Env't, 523 24 U.S. 83, 103-04, 118 S.Ct. 1003 (1998); American Civil Liberties Union of Nevada v. Masto, 670 25 F.3d 1046, 1061-62 (9th Cir. 2012). Additionally, federal courts must avoid such unwarranted 26 intervention into what is a day-to-day prison management issue. See e.g., Bell v. Wolfish, 441 27 U.S. 520, 545-46, 99 S.Ct. 1861 (1979); Griffin v. Gomez, 741 F.3d 10, 20-1 (9th Cir. 2014). The 28
