Gregory R. Arvizu (“Plaintiff”) seeks to proceed *in forma pauperis* and *pro se* with an action seeking judicial review of a determination of the Social Security Administration. Pending before the Court is the complaint (Doc. 1) and application to proceed *informa pauperis* (Doc. 2) filed by Plaintiff on January 5, 2011.

I. Proceeding in forma paueris

The Court may authorize the commencement of an action without prepayment of fees “but a person who submits an affidavit that includes a statement of all assets such person . . . possesses [and] that the person is unable to pay such fees or give security therefor.” 28 U.S.C. § 1915(a). The Court has reviewed the application and has determined that it satisfies the requirements of 28 U.S.C. § 1915(a). Therefore, Plaintiff’s Motion to Proceed In Forma Pauperis is **GRANTED**.

1 **II. Screening Requirement**

2 When a plaintiff is proceeding *in forma pauperis*, the Court is required to review the
3 complaint, and shall dismiss the case at any time if the Court determines that the allegation of
4 poverty is untrue, or the action or appeal is “frivolous, malicious or fails to state a claim on
5 which relief may be granted; or . . . seeks monetary relief against a defendant who is immune
6 from such relief.” 28 U.S.C. 1915(e)(2). A claim is frivolous “when the facts alleged arise to the
7 level of the irrational or the wholly incredible, whether or not there are judicially noticeable facts
8 available to contradict them.” *Denton v. Hernandez*, 504 U.S. 25, 32-33 (1992).

9 **III. Pleading Standards**

10 General rules for pleading complaints are governed by the Federal Rules of Civil
11 Procedure. A pleading stating a claim for relief must include a statement affirming the court’s
12 jurisdiction, “a short and plain statement of the claim showing the pleader is entitled to relief;
13 and . . . a demand for the relief sought, which may include relief in the alternative or different
14 types of relief.” Fed. R. Civ. P. 8(a). The Federal Rules adopt a flexible pleading policy, and *pro*
15 *se* pleadings are held to “less stringent standards” than pleadings drafted by attorneys. *Haines v.*
16 *Kerner*, 404 U.S. 519, 521-21 (1972).

17 A complaint must give fair notice and state the elements of the plaintiff’s claim in a plain
18 and succinct manner. *Jones v. Cmty Redevelopment Agency*, 733 F.2d 646, 649 (9th Cir. 1984).
19 The purpose of the complaint is to give the defendant fair notice of the claims against him, and
20 the grounds upon which the complaint stands. *Swierkiewicz v. Sorema N.A.*, 534 U.S. 506, 512
21 (2002). The Supreme Court noted,

22 Rule 8 does not require detailed factual allegations, but it demands more than an
23 unadorned, the-defendant-unlawfully-harmed-me unlawfully accusation. A pleading
24 that offers labels and conclusions or a formulaic recitation of the elements of a cause
of action will not do. Nor does a complaint suffice if it tenders naked assertions
devoid of further factual enhancement.

25 *Ashcroft v. Iqbal*, 129 S.Ct. 1937, 1949 (2009) (internal quotation marks and citations omitted).
26 Conclusory and vague allegations do not support a cause of action. *Ivey v. Board of Regents*, 673
27 F.2d 266, 268 (9th Cir. 1982). The Court clarified further,

28 [A] complaint must contain sufficient factual matter, accepted as true, to “state a

1 claim to relief that is plausible on its face.” [Citation]. A claim has facial plausibility
2 when the plaintiff pleads factual content that allows the court to draw the reasonable
3 inference that the defendant is liable for the misconduct alleged. [Citation]. The
4 plausibility standard is not akin to a “probability requirement,” but it asks for more
than a sheer possibility that a defendant has acted unlawfully. [Citation]. Where a
complaint pleads facts that are “merely consistent with” a defendant’s liability, it
“stops short of the line between possibility and plausibility of ‘entitlement to relief.

5 *Iqbal*, 129 S.Ct. at 1499. Where the factual allegations are well-pled, a court should assume their
6 truth and determine whether the facts would make the plaintiff entitled to relief; conclusions in
7 the pleading are not entitled to the same assumption of truth. *Id.* If the Court determines that the
8 complaint fails to state a cognizable claim, the Court may grant leave to amend to the extent that
9 deficiencies of the complaint can be cured by an amendment. *Lopez v. Smith*, 203 F.3d 1122,
10 1127-28 (9th Cir. 2000) (en banc).

11 A. Jurisdiction

12 Construed liberally, Plaintiff appears to be seeking review of a decision by the
13 Commissioner of Social Security denying disability benefits. The Court would have jurisdiction
14 pursuant to 42 U.S.C. § 405(g), which provides in relevant part:

15 Any individual, after any final decision of the Commissioner made after a hearing to
16 which he was a party, irrespective of the amount in controversy, may obtain a review
of such decision by a civil action commenced within sixty days after the mailing to
17 him of such decision or within such further time as the Commissioner may allow.
Such action shall be brought in the district court of the United States for the judicial
18 district in which the plaintiff resides, or has his principal place of business . . . The
court shall have power to enter, upon the pleadings and transcript of the record, a
19 judgment affirming, modifying, or reversing the decision of the Commissioner of
Social Security, with or without remanding the cause for a rehearing.

20 *Id.* Except as provided by statute, “[n]o findings of fact or decision of the Commissioner shall be
21 reviewed by any person, tribunal, or governmental agency.” 42 U.S.C. § 405(h). The Supreme
22 Court noted that the purpose of the legislation was “to forestall repetitive or belated litigation of
23 stale eligibility claims.” *Califano v. Sanders*, 420 U.S. 99, 108 (1977).

24 Here, Plaintiff failed to state the facts upon which the Court’s jurisdiction depends. The
25 Court will infer that by indicating a Bakersfield address on the complaint, Plaintiff alleges that he
26 resides within the Eastern District of California. However, Plaintiff has not alleged that a final
27 administrative decision was made in his case; he has not identified the type of the administrative
28 proceeding, nor has he provided the date of the decision or the date upon which notice of the

1 decision was mailed for the Court to determine whether the complaint was timely filed by
2 Plaintiff.

3 B. Requirements of the Local Rules

4 The Local Rules of the United States District Court, Eastern District of California,
5 supplement the Federal Rules. Under Local Rule 206, the following information must be
6 included in a complaint:

7 (1) In actions involving claims for retirement, survivors, disability, health insurance
8 and black lung benefits, the last four digits of the social security number of the
9 worker on whose wage record the application for benefits was filed (who may or may
10 not be the plaintiff); or

(2) In actions involving claims for supplemental security income benefits, the last
four digits of social security number of the plaintiff.

11 LR 206. Plaintiff's complaint indicates that he seeks benefits that come within this rule.

12 Therefore, Plaintiff's complaint was not in compliance with the Local Rules, as it should contain
13 the last four digits of Plaintiff's Social Security number.

14 IV. Leave to Amend the Complaint

15 If the Court determines that a complaint fails to state a claim, leave to amend should be
16 granted to the extent that the deficiencies of the complaint can be cured by amendment. *Lopez v.*
17 *Smith*, 203 F.3d 1122, 1130 (9th Cir. 2000) (en banc). A complaint, or a portion thereof, should
18 only be dismissed for failure to state a claim upon which relief may be granted if it appears
19 beyond doubt that the Plaintiff can prove no set of facts, consistent with the allegations, in
20 support of the claim or claims that would entitle him to relief. *See Hishon v. King & Spalding*,
21 467 U.S. 69, 73 (1984), citing *Conley v. Gibson*, 355 U.S. 41, 45-46 (1957); see also *Palmer v.*
22 *Roosevelt Lake Log Owners' Ass'n., Inc.*, 651 F.2d 1289, 1294 (9th Cir. 1981). Dismissal of a
23 *pro se* complaint for failure to state a claim is proper only where it is obvious that the Plaintiff
24 cannot prevail on the facts that he has alleged and that an opportunity to amend would be futile.
25 *Lopez v. Smith*, 203 F.3d at 1128.

26 Construing Plaintiff's statements in his complaint liberally, the Court cannot find with
27 certainty that he cannot allege facts, consistent with allegations, in support of the claim or claims
28 that would entitle him to relief. Plaintiff states he is "unable to be employed and need[s] the

1 courts to overturn the Social Security’s decision denying . . . benefits.” (Doc. 1 at 1). Thus, it
2 appears Plaintiff seeks judicial review of a decision denying him benefits, but it is not clear
3 whether the Court has jurisdiction over the matter. The Court will grant Plaintiff leave to amend
4 the complaint to cure the deficiencies of this complaint by stating the necessary information.
5 Failure to cure the deficiencies will result in a recommendation that the matter be dismissed with
6 prejudice.

7 Plaintiff is informed that the Court cannot refer to a prior pleading in order to make
8 Plaintiff’s amended complaint complete. Local Rule 220 requires that an amended complaint be
9 complete in itself without reference to any prior pleading. As a general rule, an amended
10 complaint supersedes the original complaint. *See Loux v. Rhay*, 375 F.2d 55, 57 (9th Cir. 1967).
11 Once Plaintiff files an amended complaint, the original pleading no longer serves any function in
12 the case.

13 The amended complaint must bear the docket number assigned this case and must be
14 labeled “First Amended Complaint.” Failure to file an amended complaint in accordance with
15 this order will be considered to be a failure to comply with an order of the Court pursuant to
16 Local Rule 110 and will result in dismissal of this action.

17 Accordingly, IT IS HEREBY ORDERED:

- 18 1. Plaintiff’s Motions to Proceed In Forma Pauperis (Doc. 2) is **GRANTED**;
- 19 2. Plaintiff’s complaint (Doc. 1) **IS DISMISSED** with leave to amend; and
- 20 3. Plaintiff is GRANTED twenty-one (21) days from the date of service of this order to
21 file an amended complaint that complies with the requirements of the pertinent substantive law,
22 the Federal Rules of Civil Procedure, and the Local Rules of Practice.

24 IT IS SO ORDERED.
