18	Plaintiff is a federal prisoner proceeding pro se pursuant to 403 U.S. 388 (1971) and has	
19	requested leave to proceed in forma pauperis pursuant to 28 U.S.C. § 1915. Plaintiff has	
20	made the showing required by § 1915(a) and accordingly, the request to proceed in forma	
21	pauperis will be granted. Plaintiff is obligated to pay the statutory filing fee of \$350.00 for this	
22	action. 28 U.S.C. § 1915(b)(1). Plaintiff is obligated to make monthly payments in the amount	
23	of twenty percent of the preceding month's income credited to plaintiff's trust account. The	
24	California Correctional Center is required to send to the Clerk of the Court payments from	
25	plaintiff's account each time the amount in the account exceeds \$10.00, until the statutory	
26	filing fee is paid in full. 28 U.S.C. § 1915(b)(2).	
27	In accordance with the above and good cause appearing therefore, IT IS HEREBY

1 2 ORDERED that:

1. Plaintiff's application to proceed in forma pauperis is GRANTED;

2. The Warden of Torrance County Detention Facility or his designee shall collect
payments from plaintiff's prison trust account in an amount equal to twenty per cent
(20%) of the preceding month's income credited to the prisoner's trust account and
shall forward those payments to the Clerk of the Court each time the amount in the
account exceeds \$10.00, in accordance with 28 U.S.C. § 1915(b)(2), until a total of
\$350.00 has been collected and forwarded to the Clerk of the Court. The payments shall
be clearly identified by the name and number assigned to this action.

3. The Clerk of the Court is directed to serve a copy of this order and a copy of
 plaintiff's in forma pauperis application on the the Warden of the Torrance County Detention
 Facility, via United States Mail.

The Clerk of the Court is directed to serve a copy of this order on the Financial
 Department, U.S. District Court, Eastern District of California, Fresno Division.

5. Within thirty (30) days of the date of service of this order, Plaintiff shall submit a
certified copy of his/her prison trust account statement for the six-month period immediately
preceding the filing of the complaint, if Plaintiff has not already done so.
