7 August 29, 2012 at 10:30 a.m. PST;

8 4. Plaintiff's counsel shall arrange a conference call between herself, Plaintiff,  
9 and Defendants' counsel (if Defendants' counsel wishes to appear), and the  
10 call shall be placed to the Court at (209) 372-8917;

11 5. The Clerk's Office shall serve this Order on Plaintiff directly, and shall serve  
12 a courtesy copy of this Order on the Litigation Coordinator at the institution;

14 6. The failure of Plaintiff to appear for the hearing may result in the imposition  
15 of sanctions deemed appropriate by the Court.
